

**Constitution  
Of  
Youth for Youth LIVE! Guam**

**A NON-PROFIT ORGANIZATION**

**ARTICLE I- NAME OF ORGANIZATION:**

***Section 1:*** The name of this organization shall be Youth for Youth LIVE! Guam hereinafter referred to as YFYLG.

***Section 2:*** YFYLG shall be a nonprofit group under the laws of the island of Guam.

***Section 3:*** YFYLG member meetings shall take place every Friday from 4:00 p.m. to 6:00 p.m. at PEACE office in Hagatna unless otherwise designated by the officers.

***Section 4:*** The meetings shall be conducted in accordance with parliamentary procedures (Robert's Rules of Order, Revised).

**ARTICLE II- PURPOSE**

***Section 1:*** The Youth for Youth LIVE! Guam (YFYLG) mission is to empower youth to live healthy lifestyles and use their creative energy to spread the drug-free message to others.

***Section 2:*** Youth for Youth Live! Guam is organized for the purpose of producing drug-free caring communities by bringing about change in youth attitudes, behaviors, and increasing knowledge, skills, and restoring peace, hope, and joy to our communities by reclaiming a drug-free way of life. To empower young people through leadership skills and instill responsibility so that teens become part of the solution. To engage teens in year-round comprehensive programs which include substance abuse education, personal growth and decision making, positive peer support for being drug-free, exposure to ideas that really work and lots of exciting drug-free fun.

***Section 3:*** Objectives:

- Provide community educational activities on Drug Abuse Prevention
- Train Youth as Trainers in Prevention
- Develop local prevention resources for youth
- Provide skill development (leadership) training for youth
- Network with other youth locally, regionally and nationally
- Strength youth and adult partnerships
- Empower youth with positive alternatives
- Foster community collaboration

**ARTICLE V-AMENDMENTS TO THE CONSTITUTION & DISSOLUTION OF ORGANIZATION**

*Section 1:* Amendments to this constitution shall be made by a majority vote of the membership present at the meeting following the meeting at which the amendment(s) are proposed for adoption. Adopted amendments shall be filed with the Guam Department of Revenue and Taxation.

*Section 2:* Amendment shall become effective upon the date stamped on the amendment filing with the Guam Department of Revenue and Taxation.

*Section 3:* The Youth For Youth Live! Guam may dissolve upon a majority vote of active members.

*Section 4:* Upon dissolution of the YFYLG, and after payment of all outstanding debts, funds remaining shall be distributed to a non-profit fund, foundation, or organization which has established its tax-exempt status with the Guam Department of Revenue and Taxation.
